message from our ceo

For 25 years, Bravehearts has been at the forefront of child protection, working relentlessly toward our Mission to prevent child sexual assault and exploitation.

As CEO of Bravehearts, it is my great privilege to reflect on this past year with admiration and respect for all involved in the important work of our organisation.

In March, we farewelled our incredible founder, Hetty Johnston AM. Bravehearts was created out of Hetty's family experience and the organisation, as it stands today, is a result of her incredible determination to champion children and their protection. We are proud as an organisation to continue this legacy. The efforts and achievements outlined in this annual report tell the story of our dedication to protect children and support those impacted by child sexual assault and exploitation.

Like many, we were hopeful that 2021 would bring much needed relief from the challenging demands COVID-19 placed on individuals and the organisation. In many ways, 2021 is proving more challenging as we navigate the broader impact of COVID-19.

Lockdowns posed varying problems for Bravehearts across different locations in Australia, with our personal safety program, Ditto's Keep Safe Adventure show for 3 to 8 year olds, being unable to be delivered face-to-face in many classrooms. Despite this, impacted teams worked hard to develop ways schools could access important safety messaging and information for parents to help keep children safe.

Bravehearts' Training team answered national requests for consent training in schools, delivered through our ProjectYou! program for youth aged 13 to 17. Child-facing organisations and schools were able to access our world-class training, ensuring children's personal safety was prioritised whilst organisations navigated lockdowns and restrictions.

Bravehearts' Therapeutic and Support Services continued adjusting to the changing environment, ensuring our services remained accessible during lockdowns and restrictions. The impact on children in lockdown is evidenced in the unprecedented increase in demand for our services. Our teams embraced eHealth options and delivered our services via a combination of in-person and eHealth platforms.

Bravehearts continues to be a proud Redress provider. Our small and dedicated 'Beyond Brave' team is considered one of the top National Redress Support Service providers with support being delivered via outreach, telephone, eHealth and face-to-face.

Bravehearts successfully delivered our 24th annual Bravehearts White Balloon Day, Australia's longest running and largest national awareness day dedicated to the prevention of child sexual assault and exploitation. Thank you to everyone who partnered with us, fundraised, or donated on this important day.

COVID-19 lockdowns impacted our 777 Marathon greatly, with the event being forced to move to five marathons in three Queensland locations. Despite this, the event was very successful, demonstrating our supporters' tireless commitment to child protection.

Lockdowns and the subsequent increased time children are spending at home and online has further developed the focus toward preventing online child exploitation. Our partnership, as a stakeholder of the ACCCE (Australian Centre to Counter Child Exploitation), was further enhanced as we collaborated on key projects including Closing the Net, a ten-part informative and ground-breaking podcast on child sexual exploitation.

As we look back over our achievements through complex and challenging times, we also look to the future. We unreservedly continue our commitment to shine a light on



child sexual assault and exploitation, break the silence and stop this crime from being further stigmatised. We must keep protecting our children as their future depends on it.

To our Bravehearts staff, supporters, volunteers, ambassadors, National Board members, funders, Police, corporate partners, Government partners, Executive Research Advisory Panel and to all who fly the Bravehearts flag, we express our deepest gratitude - without you, our work is not possible.

preventing child sexual assault and exploitation

Bravehearts' 3 Piers to Prevention - Educate, Empower, Protect - guide our work towards our Mission of preventing child sexual assault and exploitation, as well as helping us to assess systemic gaps and identify key priorities for lobbying and reform.

Empower

All adults are trained, aware and motivated to protect children, and adequate specialist counselling and support is available to child and adult survivors of child sexual assault and those who support them.

Bravehearts is working towards reaching this benchmark through the provision of:

- Counselling and support to children and young people who have been affected by child sexual assault, and their non offending family members;
- Early intervention programs for young people engaging in, or at risk of engaging in, harmful sexual behaviours;
- Case Management support for adult survivors of historical, institutional child sexual abuse wishing to access the National Redress Scheme;
- Child protection training for those working with and caring for children and young people;
- Advisory for child-serving organisations.

Educate

All children and young people receive evidencebased, age appropriate personal safety education.

Bravehearts is working towards reaching this benchmark through the provision of:

- Personal safety education programs and resources for children and young people; and
- Cyber-safety, sexual safety and respectful relationships programs and resources for children and young people.

Protect

All systems of community and government engage effectively and respond, at all times, in the best interests of the child.

Bravehearts is working towards reaching this benchmark through the provision of:

- Research;
- Policy development;
- Lobbying and legislative reform; and
- Reporting schemes.



Trauma-informed Counselling

Bravehearts provides counselling services to:

- Children and young people who have experienced or are at risk of experiencing child sexual assault;
- Their non-offending family members including parents, partners, siblings and others;
- Children under 12 engaging in problem sexual behaviour [NOTE: Young people aged 13-17 with harmful sexual behaviour are referred to Bravehearts' Turning Corners program].

Bravehearts Therapeutic Services had a successful year, welcoming three new clinicians into the Springwood team and a Team Co-ordinator overseeing the Arundel and Springwood teams.

The shift in COVID-19 saw our counsellors and clients alike embrace change and exercise flexibility in delivering and receiving counselling via our eHealth platform. Flexible service delivery has positively impacted client engagement, particularly with carers utilising tele-health and eHealth options when unable to attend in person.

Client confidentiality, wellbeing and safety are always managed with care and diligence. Clinicians continue to work within a multi-disciplinary framework to provide support to children who have experienced or at risk of experiencing sexual abuse and their non-offending family

Flexible work arrangements due to COVID-19 has brought about an increased awareness amongst Clinicians of engaging in regular self-care practices and staying connected with the wider organisation to support their own wellbeing. Our clinicians continue to passionately deliver therapeutic support with evidence-based interventions when working with clients.

Bravehearts Information & Support Line

Bravehearts' National Information and Support Line (1800 272 831) can be accessed by anyone wanting information or support relating to child sexual assault and exploitation. Our toll free 1800 272 831 Support Line is open from 8:30am to 4:30pm Monday to Friday AEST (hours vary on public holidays). Our Information Officers can provide confidential support and advice regarding, but not limited to:

- · Immediate crisis support following a recent disclosure;
- Support on how to make a report to state child protection or police (including advice regarding mandatory reporting);
- Advice on what to expect when accessing support and responding to disclosures or difficult behaviours;
- Referrals and information to access appropriate support services.

The Bravehearts Information and Support Line (BISL) team have been able to support 184 families responding to disclosures and provided 297 families with advice regarding sexual behaviour problems. Additionally, our Information Officers have been able to respond to 32 queries regarding family law court matters and supported 371 individuals regarding historical child sexual assault matters.

For the period 1 July 2020 to 30 June 2021, BISL:

- Received 4396 calls;
- Responded to 516 emails;
- Conducted 403 intake sessions; and
- Made 62 Child Safety Notifications.

The Courage Project

The Courage Project is a collaboration between Bravehearts and Mackay Women's Services, funded through the North Queensland Primary Health Network.

The program provides trauma-informed mental health services to children aged up to 14 throughout the Mackay, Whitsunday and Isaac regions who have experienced or are at risk of experiencing child sexual assault or physical violence. In addition to counselling services, The Courage Project engages in and facilitates community events and education.

The Courage Project officially launched in Mackay in October 2020. With a service delivery footprint of over 90,000km², The Courage Project created working relationships with the Queensland Police Service Criminal Investigation Bureau and Child Protection Unit in the Sarina and Moranbah (Isaac) regions.

These partnerships allowed for prioritisation of referrals, immediate support from Child and Family Advocates, and increased service delivery.

The Courage Project also created working relationships in Bowen, Airlie Beach, Sarina, Moranbah and Middlemount with several schools, PCYCs, Non-Government Organisations, and government offices including Department of Children, Youth Justice and Multicultural Affairs.

Working closely with existing service supports and providers is a key feature of this program. The Courage Project recognise the importance of working collaboratively with other services and supports to provide families with best practice.

In late 2020, the Mackay NAIDOC Committee extended an invitation to The Courage Project's Practice Manager to be a part of the committee in preparation for NAIDOC week in July 2021. The Courage Project was also invited to join the LGBTQIA+ Planning Committee and participated in Mackay's first annual Pride March.

The Courage Project hosted two open community events with the Bravehearts Beyond Brave team, with the aim to educate the community on available services and provide information on Child Sexual Assault prevention in collaboration with information regarding the Redress Scheme.

As part of our commitment to educating and supporting the wider community, The Courage Project hosted a number of open community forums jointly with Bravehearts' Redress team (Beyond Brave). Additionally, we facilitated two parent and community education forums during June 2021.

The Courage Project Practice Manager presented at the Closing the Gap Forum facilitated by Northern Queensland Primary Health Network and Hospital Health Service (HHS) in June 2021. The forum focused on creating and growing a healthy future for our Aboriginal, Torres Strait and South Sea Islander communities and improving health and service delivery for the next generation.

The presentation was titled "Working with children and families impacted by trauma; a service response to an identified gap" and discussed The Courage Project's framework and service delivery along with the impact trauma has on child development.

During the 2020/21 financial year, The Courage Project

- 316 counselling sessions (October to June)
- 64 outreach sessions (Sarina, Whitsunday, Isaac)
- 94 phone/Dokotela sessions
- 3 community forums (52 attendees)



Multi-Agency Service Response (MASR) Child & Family Advocate

In 2021, Bravehearts was successful in receiving short term funding for 6 months to re-establish the Child and Family Advocate support through our Multi-Agency Service Response (MASR), which was previously funded in 2018. Bravehearts' Child and Family Advocate offers families assistance in accessing the support they need and guides families through the child's journey towards healing.

The Child and Family Advocate provides the below support in the Logan and Gold Coast regions:

- Assisting a child/family to provide a 93A statement to police. This can occur at Bravehearts child friendly Arundel office or at police stations within the catchment areas.
- Provide case coordination and crisis support within a case planning approach.
- Provide ongoing liaison support and referrals as required.

Although the Child and Family Advocate Role has only been running for a short period, it has been gaining traction and has been welcomed by Police and other government and community groups who are frequently coming into contact with children and families who have been affected by child sexual assault and exploitation.

The role of the Child and Family Advocate has proven beneficial to clients and their families, with many commenting on the warm welcoming environment at Bravehearts and support provided at the point of need by the Child and Family Advocate.

The most notable achievement thus far, has been the seamless ability to re-establish the previous relationships with key community stakeholders.

Since the beginning of January 2021, the Child and Family Advocate has re-engaged with several agencies, by way of either attending community meetings or providing a presentation to a particular service.

The Child and Family Advocate has had opportunities during presentations to provide further education to service providers around responding to disclosures of child sexual assault and exploitation plus supporting families navigate the often-complex journeys of child sexual assault and exploitation.

Informal education around police processes and the criminal justice system has been a topic of interest presented to multiple agencies.

The Child and Family Advocate has provided over ten presentations to agencies within the Gold Coast and Logan regions including Wesley Mission, GC Health Child Protection Unit, Child and Youth Metal Health Service, YHES House, Logan Centre for Women and Co, DVPC, GC Youth Service, GC Centre Against Sexual Violence, Parents Next and GC Community Legal Centre. There are plans to continue the offering of these educational presentations for the remainder of the funding period.

Clients engaged in MASR over the 6 month period:

- Logan: 11 clients
- Gold Coast: 47 clients
- Total clients engaged: 58

The Child and Family Advocate has been providing a holistic approach to support which includes warm referrals to help clients access suitable services to meet their individual and family needs.

Feedback from clients has been received informally by the Child and Family Advocate. Feedback from parents and guardians of children who have been supported regarding what to expect with a 93A, have reported that "it was nice to see them (the children) a bit more relieved about it". Other families have offered that "You have been an amazing support" and generally appreciate the idea that the Child and Family Advocate is in their corner.



Turning Corners

The Turning Corners Program is an initiative of Bravehearts that provides comprehensive and integrated responses to working with vulnerable young people. The program caters for youth aged between 12-17 and up to 21 for individuals with an intellectual impairment, who have engaged, or are at risk of engaging, in harmful sexual behaviour. Bravehearts Turning Corners Program is supported by Hand Heart Pocket, the Charity of Freemasons Queensland.

Turning Corners was established as an early intervention program built on the understanding that young people engage in harmful sexual behaviours for a wide variety of reasons ranging from curiosity to previous trauma. The program provides an alternative pathway that allows young people who have or are at risk of, engaging in harmful sexual behaviour to receive support earlier, change their behaviour, avoid contact with the criminal justice system, and above all, prevent other children and young people being harmed. Treatment involves drawing on the strengths of the client and has a strong focus on improved outcomes for the client, their family and the community.

After successfully receiving funding through Hand Heart Pocket, the Charity of the Freemasons Queensland in late 2020, the program has expanded to provide counselling and advocacy support to youth and their families throughout Queensland. Of significance, we implemented a Child and Family Advocate to assist youth and their families navigate and understand the service system and access support to meet their needs. The Turning Corners Child and Family Advocate role provides a holistic wraparound support to adolescents and their families/carers who engage in the program using a biopsychosocial model and family systems framework.

Since its inception, there has been a growing demand for the Turning Corners Program, which now sees clients in various sites across Queensland. The program delivers an outreach and support model and has successfully delivered services to young people within their school, Out of Home Care, Youth Justice facilities and remotely via online videoconferencing platform. Due to the specialist knowledge and skills of the staff involved in this program, we have seen a growth in requests for the service. Over the 2020/2021 financial year, Turning Corners clinicians have delivered more than 636 individual counselling sessions, reaching over 55 individual young people and their families.


Our program implements a needs-led approach which considers the key needs that a young person is trying to fulfill through these behaviours. We undertake a holistic approach with each young person, many of whom have been impacted by trauma themselves. Through our work, we address the wellbeing of the young people engaged, assist them to increase the possibilities for them to lead a more positive life, and create a sense of optimism and empowerment through the work that we undertake.

The program saw a significant increase in referrals received during 2020/21 in comparison to 2019/20. We received 95 new referrals for counselling, highlighting a substantial increase from previous years. Whilst we expanded the staffing compliment during this time, the escalation in referrals remains a substantial accomplishment for the program.

We recognise that harmful sexual behaviour is a complex area of work, but when we look at it through a cultural lens, there is so much more that needs to be done in this space. Over the last financial year, the program has supported 9 Aboriginal clients and a further 5 culturally and linguistically diverse clients. We continue to work towards ensuring cultural inclusiveness is applied to the program.

Whilst the team is based in South East Queensland, it supports clients across the State via our eHealth platform.

To date, a significant percentage of referrals to the program come from Youth Justice through their alternate restorative justice pathway, with 14 referrals received in the last financial year alone. We have received a further 60 referrals from other agencies including but not limited to police, schools and GP's.



Beyond Brave

Beyond Brave is Bravehearts' National Redress Support service funded by the Department of Social Services to provide support to people who have experienced sexual abuse as children in institutional contexts.

Beyond Brave offers telephone, online and face-to-face support within South-East Queensland and outreach services to North Queensland.

This financial year, Bravehearts' Beyond Brave team:

- Spent 3,168 hours assisting, supporting and advocating on behalf of adult survivors;
- Made 12,070 total contacts with Adult survivors (including phone, email, eHealth, outreach, letter and in-person contacts);
- Provided support to 419 clients seeking Redress
 Support (Males = 274, Females = 145);
- Assisted 118 clients to submit Redress Applications to the National Redress Scheme:
- 73 clients received an outcome from the Scheme in this financial year.

This financial year, Beyond Brave continued to provide targeted outreach Redress Services to North Queensland, with a focus on Aboriginal and Torres Strait Islander communities and this has led to a 77% increase in demand for our services from the previous financial year.

In addition, Beyond Brave has continued to advocate for improvements to the implementation and operation of the National Redress Scheme. In September 2020, Beyond Brave provided a written submission to the Independent Review of the National Redress Scheme highlighting several areas where improvements are needed in order to ensure that the scheme delivers on its objective of providing justice to survivors.

Beyond Brave was also invited to work with Gilimbaa as part of the National Redress Scheme Northern Australian Indigenous Communication and Engagement Strategy providing feedback and input into the Media Strategy as well as recording a media interview that would be used as part of this strategy for Queensland Remote Aboriginal Media.

Ditto's Keep Safe Adventure Show

Bravehearts' Ditto's Keep Safe Adventure show is a live, interactive personal safety program for children aged three to eight, featuring Bravehearts' lion cub mascot 'Ditto'.

Established in 2006, the Ditto program teaches children essential personal safety skills and body ownership using age-appropriate language, song and dance.

Bravehearts' nine education teams deliver the Ditto program to children in childcare centres, kindergartens and primary schools throughout the East Coast of Australia from Far North Queensland to Tasmania. Ditto's Keep Safe Adventure show reached its one millionth child milestone in September 2019 and has now been seen by over 1,151,592 children nationally.

Thanks to generous funding through grants, philanthropy, and partnership agreements in 2021/21, we were able to welcome a new education team back into Sydney. The team commenced in March 2021 and as at the end of June 2021, saw more than 3.300 children at over 55 shows.

Bravehearts also welcomed a second Brisbane team who commenced delivery in April 2021, expanding the reach available to service regions in South East Queensland.

Due to the ongoing COVID-19 lockdowns in Melbourne,
Bravehearts has been unable to continue with an active team
in the region. While we wait for a return to a new 'normal' we
continue to seek a new premises for this team. Meanwhile
our enquiries for this region continue to grow as we look at
alternative options for delivery.

Despite these challenges, during the 2020/21 financial year, our education teams saw over 22,000 more children than the previous financial year; a credit to the dedication of our committed education facilitators.

Ditto in a Box

Aligning with the Early Years Learning Framework, Ditto in a Box is an in-class resource that compliments Ditto's Keep Safe Adventure show, which can be used as a standalone resource, available in primary and early years formats. It includes the principles, practices, learning outcomes and quality areas that make up assessment.

Created in conjunction with the live show and using the same principles and messaging, these resources are designed to support and equip teachers and educators with tools, knowledge, and language to create and maintain a nurturing environment in the areas of health, wellbeing, community and safety.

During the past financial year, Bravehearts saw a 29% increase in Ditto in a Box sales, with 63 Ditto in a Box for Primary (ages 5 to 8) sold and 198 Ditto in a Box for Early Years (ages 2 to 5) sold.

ProjectYou!

National attention on gendered violence, particularly in the past year, has resulted in a push from young people for greater education about safety, consent and respect in Australian schools.

An online petition started late last year by former Kambala School student, Chanel Contos, in which thousands of current and former high school students shared stories of the sexual violence they experienced, demonstrating the seriousness of the problem at all levels of Australian society. The campaign website boldly stated the intentions of the petition, which garnered over 44,000 signatures from young people:

"As a collective, we call for sexual consent to be at the forefront of educational issues in school, from a young age."

As a result, Australian high schools are starting to listen to the voices of the young people, and this has sparked a significant increase in demand for Bravehearts' consent and respectful relationships program, ProjectYou!.

In the 2020/21 financial year, ProjectYou! was delivered to 5,160 students, a 77% increase in delivery from the previous year.

ProjectYou! explores the concepts of respectful relationships and personal safety for young people aged 12 to 18 years, presented in flexible formats and varying durations to suit the school's needs.

Topics include asserting personal boundaries, resolving conflict, consent and the impacts of pornography.

ProjectYou! continues to evolve each year as the program reaches more young people and we continually improve the content based on student feedback.

Like our adult learning programs, ProjectYou! introduced videoconferencing formats in the past two years, enabling Bravehearts to continue delivering the program in the United Kingdom and Europe after losing our on-the-ground overseas team to lockdowns. Thanks to philanthropic support, from Civic Solutions Inc, Bravehearts was able to invest in custom motion animations to enhance the content and further improve student engagement.

Child Protection Training

Bravehearts' child protection courses and workshops support and nurture child safe environments within organisations that work with and in the service of children and young people.

The 2020/21 financial year surpassed expectations for Bravehearts' training services in the face of uncertainty, with many of the sectors we support adversely affected by COVID-19.

Our focus on the digitalisation of our services to eLearning and virtual classrooms proved successful with most planned sessions transitioning to video conferencing and bespoke eLearning modules.

A total of 179 workshops or presentations were delivered to approximately 7,500 people across both in-person and virtual classroom formats. There is now a proven appetite for our virtual classroom and webinar offering, so this will continue as a standard service permanently.

Our eLearning capability was enhanced considerably with the introduction of new eLearning specialists and investment in eLearning tools. This has resulted in more visually appealing and interactive learning experiences for our clients. Despite the significant disruptions to schooling and other child-serving sectors, our eLearning participation increased from the previous year with a total of 4,615 registered learners.

A highlight of the year was the relaunch of our 'Child Protection for Early Years Educators' course.

Accompanied by our nationally recognised unit of competency, 'Identify and Respond to Children and Young People at Risk', offered in partnership with PCYC Institute, Bravehearts now has a comprehensive offering for educators working with children under five.

Bravehearts' holistic approach to child protection training for schools continues to be popular with large independent schools, who realise the benefits of role-specific learning experiences for every staff member, volunteer, parent/carer and student. As each jurisdiction across the country adopts the recommendations of the Royal Commission, we foresee the demand for this work only increasing.

Advisory Services

A feature of our advisory services is the ChildProtect
Program which supports organisations to examine their
child protection risk exposures and develop a roadmap
toward best practice implementation of the National
Principles for Child Safe Organisations.

While this offering was affected by COVID-19, those organisations that have engaged with the service now better understand their child protection risks and have implemented more effective mitigation strategies, including education and training services.

ChildPlace, our partnership with EY, also continued this year.

This is a crucial partnership in our work to support larger scale entities and Government Departments implement child safe practices to enhance their organisational child safe culture.

Podcast

Bravehearts launched The Parent's Podcast series on Safer Internet Day in February 2021, with hosts Carol Ronken, Bravehearts' Director of Research, and Mathew Sinclair, Bravehearts' National Child Protection Training Manager. The series featured interviews with industry experts, including Julie Inman Grant, eSafety Commissioner; Professor Darryl Higgins, Director of the Institute of Child Protection Studies; Detective Acting Inspector Jon Rouse of the Australian Centre to Counter Child Exploitation; and Maree Crabbe from It's Time We Talked. The next season of The Parent's Podcast is currently in production.

Research

Bravehearts' research team was busy kicking off some incredible projects during 2020/21 and its role within the organisation expanded, with greater involvement in the development and review of programs and services.

The research team continues to grow a program of work that:

- focuses on the development of an evidence-based response for addressing child sexual assault and exploitation;
- contributes to child sexual assault and exploitation research and literature;
- is proactive in lobbying and legislative reform;
- ensures best practice of operational services; and
- develops community and sector knowledge plus awareness.

In the latter half of 2020, Bravehearts engaged the Institute of Child Protection Studies to complete a rapid evidence check on research and literature that supports 'what works' in relation to child sexual abuse prevention programs. This critical piece of work is helping to inform a review of Bravehearts' Ditto's Keep Safe Adventure program to ensure that the content is in line with best-practice.

Bravehearts successfully attained an Australian Institute of Criminology, Criminology Research Grant with lead partners at the Queensland University of Technology (Dr Jodi Death, Associate Professor Kelly Richards, Dr Michael Chataway and Mr Chris Emzin).

This research is an extension of the work we did with Jodi Kelly and Professor Kieran McCartan (University of the West of England) in 2019/20, exploring the views survivors held about the post-release Circles of Support and Accountability program for those who have committed sexual offences. This new project will document, for the first time globally, the views of survivors of sexual violence about post-release sex offender reintegration.

Bravehearts has also partnered with researchers from the University of South Australia and the University of Haifa (Israel), in partnership with Anima-ey (Israel) to research the utility of artificial analysis of children's self-figure drawings in cases of known or suspected child sexual abuse in respect to the therapeutic process. The system, developed by Anima-ey, has been tested in initial trials with promising results. Bravehearts joined the team to explore the system further and to hopefully refine its application. Data collection will begin in the second half of 2021.

In 2020/21, Bravehearts began a research project exploring young people's digital relationship. Bravehearts' Senior Researcher, Dr Rebekah Chapman ran several focus groups with young people, along with our research partner Dr Jeremy Kerr. We have now begun to explore the transcripts and pull-out themes and will look at publishing this research in 2022.

Bravehearts has also developed a research partnership with Dr David Butler & Dr Tiffany Howell (La Trobe University), exploring support dog use in therapy with children who have been sexually abused.

Bravehearts' 777 Marathon 2021

Bravehearts' 777 Marathon is Australia's mightiest ultramarathon that sees participants running 7 marathons in 7 states in 7 consecutive days.

The 777 Marathon (777) started in 2013 as a unique way for individuals to raise funds and awareness for Bravehearts and the prevention of child sexual assault and exploitation.

COVID-19 travel and border restrictions continued to affect 777 this year. The traditional format of the event taking place across seven states was revised, with all seven marathons planned to take place in Queensland only (Toowoomba, Brisbane, Mount Isa, Cairns, Townsville, Mackay and Gold Coast). This decision was made to help mitigate risk for both the runners and the event itself.

Unfortunately, as this pandemic has demonstrated, changes to plans are quickly forced. Just one day into the event, several Queensland Local Government Areas were plunged into lockdown and South East Queensland declared a hotspot.

This foiled our travel ability and posed too great a risk to our runners, so quick decisions were made to reduce the event locations, with some runners choosing to fly home to their respective states and complete the challenge virtually.

Despite the COVID-19 spanner being thrown into the works, our 777 runners, staff and volunteers made the best out of the situation and still managed to have fun, run and raise much-needed funds for Bravehearts.

Bravehearts' White Balloon Day 2020

Established in 1996, White Balloon Day is Bravehearts' signature annual awareness and fundraising campaign.

Bravehearts' White Balloon Day 2020 was held on Friday, 11 September, during National Child Protection Week.

The call to action for the 2020 campaign was to 'wear white and donate to protect kids'. Despite fundraising events and activities being impacted by COVID-19 restrictions and lockdowns, the campaign saw high engagement on social media with supporters posting selfies and messages of support in the lead up and on Bravehearts White Balloon Day.

The campaign saw the introduction of a giving day, which occurred on the actual day of Bravehearts' White Balloon Day, with support from Superannuation Advice Australia who matched donations on the day, up to \$50,000.

Bravehearts used the 2020 White Balloon Day campaign to debut our new fundraising platform (Funraisin), which streamlined the registration process and simplified online fundraising for supporters.

The clear call to action coupled with the giving day and the introduction of this new fundraising platform resulted in our most successful Bravehearts White Balloon Day to date with a total of \$195,371 raised.

Bravehearts White Balloon Day 2020 was funded by a grant from Department of Social Services (DSS), National Initiatives.

The 24th Annual Bravehearts Ball

The 24th Annual Bravehearts Ball in support of White Balloon Day was held on Saturday 22 May, 2021 at Brisbane City Hall. Traditionally the Ball is held in conjunction with White Balloon Day during Child Protection Week in September, however COVID-19 restrictions forced us to postpone the 2020 Ball and move it to May 2021.

This move greatly benefited the event, with attendance and funds raised higher than any other preceding year.

450 guests attended the night and enjoyed a three-course meal, drinks, live music, live auction, silent auction and raffles.

Margaux Parker MC'd the evening and speakers included The Hon Michelle Landry MP, Bravehearts CEO Alison Geale, Hetty Johnston AM, and Robin Bailey.

Paul de Jersey AC Patron in Chief

Mr de Jersey AC practised law in Queensland and was called to the Queensland Bar in 1971. He took silk in 1981 as one of Her Majesty's Counsel (QC).

He was appointed a Judge of the Supreme Court of Queensland in 1985 and was the Commercial Causes Judge between 1986–1989. He was the judge constituting the Mental Health Tribunal between 1994–1996, President of the Queensland Industrial Court between 1996–1997 and was also the chairman of the Law Reform Commission of Queensland during that time.

He was Chief Justice of Queensland between 1998-2014 and appointed Queensland Governor on 29 July 2015.
